

TERMS AND CONDITIONS

INSTANT WIN GAME BONUS DRAW – WIN A HOLIDAY WORTH €5,000 – SEPTEMBER 2026

1. The National Lottery Digital Instant Win Game Bonus Draw Event (the “Event”) is open to persons who have registered to play National Lottery games via the National Lottery website or National Lottery App and, for the avoidance of doubt, have satisfied the various Player criteria as set out in the National Lottery website Terms and Conditions.
2. The Bonus Draw Event is open from 6:00AM, 25th September and closes 11:00PM, 4th October 2026.
3. On the specified date, all digital players (registered players who play on the National Lottery website and/or National Lottery App) with at least one play of any national lottery Instant Win Game during the specified period will be entered into a draw.
4. Each player will be allowed one entry, irrespective of the number and cost of plays made during the period.
5. Players who are self-excluded will be removed from the draw and are ineligible to win the associated prize.
6. The winner will be notified within 7 working days from draw close via a verified National Lottery email address or National Lottery phone number.
7. Following verified contact with the winner, the winner’s county may be announced via email, social media and on the website.
8. In the event that the winner cannot be contacted within the permitted 90 days, the prize will be move to the next player on the winning reserve list.
9. The winner may elect to receive the prize in the form of a holiday voucher to the value of €5,000 or the cash value of the prize payable via electronic transfer where possible, otherwise by cheque.
10. The Bonus Draw prize will be dispatched from The National Lottery within 90 days of winner confirmation.
11. The National Lottery will have no responsibility or liability for any loss, damage or injury which may be suffered as a direct or indirect result of acceptance of any of the prizes.
12. The winner must be aged 18 years or over and their National Lottery account must be ID verified.
13. The National Lottery reserves the right to withdraw or amend this Bonus Draw event and/or these terms and conditions in the event of any unforeseen circumstances.
14. Entrants are deemed to have accepted these terms and conditions by participating in this Bonus Draw Event.
15. The decisions of the National Lottery in respect of any disputes arising from this Bonus Draw Event will be final and binding on all participants.
16. If any provision of these Terms and Conditions is found to be void, unlawful or unenforceable for any reason, that portion shall be deemed severable from these Terms and Conditions. This shall not otherwise affect the validity and enforceability of any remaining provisions.
17. This Bonus Draw Event and these terms are governed by the laws of Ireland and are subject to the exclusive jurisdiction of the Courts of Ireland.
